In that role, she has done speaking throughout the world as an evangelist for gender parity and an outspoken advocate for expanding the ranks of women leaders at corporations, non-profits and other institutions. She will be teaching a law school course on Leadership for Lawyers in the Fall.

Hilarie has also served as the Chair of the Board of Trustees of the University of Miami, and is a current Board member of UHealth, a \$5 billion healthcare Company. She also is the current Co-Chair of the ABA's Center for Practice Innovation, and a Board member of the ABA Retirement Fund. She is a graduate of the University of Miami School of Law where she graduated Summa Cum Laude.

Judge Laurel Beatty Blunt Tenth District Court of Appeals

Judge Laurel Beatty Blunt is a dedicated jurist, educator, and civic leader who has worked to advance the status of women in the legal profession and the Columbus community. A magna cum laude graduate of Spelman College, she earned her law degree from Vanderbilt University Law School. Before taking the bench, she built a distinguished litigation career at Frost Brown Todd, Kegler Brown Hill + Ritter, and Otto Beatty Jr. & Associates, and served as Director of Legislative Affairs and Counsel to the Voting Rights Institute for the Ohio Secretary of State.

Appointed to the Franklin County Court of Common Pleas in 2009, she presided over complex civil litigation and serious felony criminal cases. In 2018, she made history as the first Black woman on Ohio Tenth District Court of Appeals, where she continues to serve. Judge Beatty Blunt taught at the University of Michigan Ford School of Public Policy about the role of state and local courts and the impact of U.S. Supreme Court decisions. She is also a sought-after speaker, sharing insights on the law and leadership with students and young attorneys.

Her contributions to the legal field have been widely recognized. In 2023, she received an Honorary Doctorate from Franklin University and the YWCA Columbus Woman of Achievement Award.










Caitlyn Nestleroth Johnson




LeeAnne Cornyn Director of the Ohio Department of Mental Health and Addiction Services



Jenni Edwards Partner, Porter Wright






Emily Quick Shriver Chief Executive Officer, The Matriots




Lizett Martinez Schreiber Managing Attorney & Chief Projects Director, Ohio Justice & Policy Center




Shanrika S. Hall Counsel, Nationwide







Chris is dedicated to helping clients and forming long-term relationships, whether through proactive risk mitigation or successfully advocating for them in court.



Family Friendly Award

With gratitude for the role it has played for many years, the OWBA Board has, upon thoughtful reflection, decided to retire the Family Friendly Award. This award was the first award created by the OWBA. No one else was publicly recognizing those legal employers that were going the extra mile to show concern for the challenges faced by women lawyers. Each year, this award recognized a legal employer in Ohio who best exemplified the commitment to flexible work arrangements and assured that all lawyers (not just women lawyers) could take care of their families and still pursue a successful career.

This award played an important role for the time that it existed. But we as a Board have concluded that it has run its course. Are things fixed? Not by a long shot. Affordable, quality child care remains a crisis, not just for lawyers but for all Ohioans. The assumption that women are the primary caregivers in a family continues to run strong. But Covid changed a lot. Many legal employers were forced to acknowledge and accept flexible work arrangements, which are now widespread. And awards like this have caused employers to change their policies from "maternity leave" to "parental leave," and recognize that other forms of caregiving (elder care) may require flexibility or time away from work. A new generation of fathers feels empowered, in ways prior generations did not, to use those benefits. And we have since adopted other awards that also recognize and applaud legal employers who demonstrate a mindfulness of the endless variety of kinds of people, situations, and lawyers our profession includes.

Perhaps equally importantly, as a women's organization, we do not wish to be seen as implicitly endorsing the presumption that the bulk of the "home and family" responsibilities should fall on the woman. Caregiving is a family issue, not a women's issue. And so, with endless appreciation for our predecessors who realized the importance of publicly recognizing legal employers who demonstrate care for the well-being of their employees, we say a grateful farewell to the Family Friendly Award.






